Statement

All India Radio Code

Advertising and Children

18. No advertisement for a product or service shall be accepted if it suggests in any way that unless the children themselves buy or encourage other people to buy the products or services, they will be failing in their duty or lacking in loyalty to any person or organisation.

19. No advertisement shall be accepted which leads children to believe that if they do not own or use the product advertised they will be inferior in some way to other children or that they are liable to be eon-deHined or ridiculdt for not owning or using it.

Doordarshan Code

Advertising and Children

22. No advertisement for a product or service shall be accepted if it suggests in any way that unless the children themselves buy or encourage other people to buy the products or services, they will be failing in their duty or lacking in loyalty to any person or organisation.

23. No advertisement shall be accepted which leads children to believe that if they do not own or use the product advertised they will be inferior in some way to other children or that they are liable to be condemned or ridiculed for not owning or using it.

24. Any advertisement which endangers the safety of the children or creates in them any interest in unhealthy practices, shall not be accepted, e.g. playing in the middle of the road, leaning dangerously out of a window, playing with match boxct and other goods which can cause accidents.

25. Children shall not be shown begging or in an undignified ar iadeeeat Banner.

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA CYAS) : (a) No, Sir.

Augmentation of capacity of AIR's Solapur Station

1292. SHRI SUSHILKUMAR SAMBHA JIRAO SHINDE: Will the Minister of INFORMATION AND BROADCASTING be pleased to state :

(a) whather it is a fact that the All India Radio Station at Solapur in Maharashtra is meeting the demands of the citizens of Solapur and neighbouring places.

(b) whether any survey has been conducted by the AH India Radio to augment the capacity of its Solapur Station;

(c) if so, the details thereof; and

(d) if not Whether Government would consider conducting such a survey in the near future ?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS) : (a) The 1 KW MW local Radio Station at Solapur is serving the purpose for which it has been established.

(b) to (d) The power of the transmitter is considered adequate for local radio station and no field strength survey has been conducted. There is also no proposal to augment the power of the existing transmitter as there is no frequency assignment beyond 1 KW MW power for Solapur under International Telecommunication Union Plan.

Coverage of entire Maharashtra by Second Channel of Doordarshan

1293. SHRI SUSHILKUMAR SAMBHARAO SHINDE : Will the Minister of INFORMATION AND BROADCASTING be pleased to state :

(a) whether Government are considering a proposal for coverage of the entire State of Maharashtra under the Second Channel of Doordarshan;

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS) : (a) and (c) The VIII Plan proposals of Doordarshan do not include provisions for the introduction of "Second Channel" service of Doordarshan from any Doordarshan Kendra in the country. However, with a view to meet varied requirements of the viewers in the metropolitan city a "second channel" service is already in operation at Bombay since May,

1985. Besides, a satellite-derived regional TV service is, also in operation in the State of Maharashtra- since August, 1986. ,

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS) : (a) Total grant of Rs. 3,98,00,000 was released to the National Film Centre of Children and Young people (previously known as Children Film Society of India) during the last three financial years;

(b) The revenue/income earned by the society during the last three financial years was (Rs. 2,06,86,715. , , ,
