#### Cut in the Hessian Price by Bangladesh

(a) whether it is a fact that the Bangladesh has cut hessian prices by about \$2 to \$14 against India's price of about \$14.70 per hundred yards thus affecting the prospects of Indian exports to hard currency areas; and

(b) if so, what is Government's strategy to overcome this ?

THE MINISTER OF STATE OF THE MINISTRY OF TEXTILES (SHRI ASHOK GEHLOT) : (a) Bangladesh has reduced the prices of hessian from US\$ 17 per hundred yards a few months ago to the current level of around US\$14 per hundred yards.

(b) Competitive prices are offered by Indian exporters keeping in view the market demand and supply position.
