Railway accident occured at Hissar on
28th September, 1992

1497. SHRI RAMJI LAL: Will the Minister of RAILWAYS be pleased to refer to the answer of Unstarred Question 381 given in Rajya Sabha on 25th November, 1992 and state:

- (a) whe'her any inquiry has been ordered by Government into the accident, occurred to Train No. 4 HSP at Hissar on 28th September, 1992;
 - (b) if so, what are the details thereof;
- (c) whether it is a fact that the required compensation has not been provided to the victims so far: and
- (d) if so, the reasons for delay and the time by which it is likely to be paid?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MALLIKARJUN): (a) and (b) Yes. Sir. The accident was inquired by the Commissioner of Railway Safety, Northern Circle. According to his findings, the accident occurred due to the gate of level crossing being kept open by the Galeman at the time of passage of passenger train. In this accident, 7 persons lost their lives and 4 sustained injuries. The Gateman has been found responsible for this lapse.

- (c) Yes, Sir.
- (d) No claim application has been preferred by next of the kin of the victims so far. Compensation will be paid in due course as soon as award is given by the Railway Claims Tribunal on considering the merits of the cases filed.

Passenger train on Sadalpur-Hissar Section

1498. SHRI, RAMJI LAL: Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that the passenger trains on Sadalpur Hissar Section of Northern Railway always run behind their scheduled time;
- (b) if so, the number of times these trains have desailed/met with accidents since January, 1992, and the persons died as a result thereof;
- (c) if so, whether it is a fact that the accident occurred on 28th September, 1992 to train Route No. 4 HSP at Hissar is the most severe accident; and
- (d) if so, the details thereof alongwith the details of compensation paid to the kith and kins of the victims?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MALLIKARIUN): (a) The punctuality of passanger (rains on Sadulpur-Hissar section during September '92 and October '92 has been averaging 81% mainly on account of equipment failures in steam locomotives.

(b) to (d) There has been only 1 train accident on Sadulpur-Hissar section since January, 1992. This occurred on 28-9-92 at Level Crossing Gate No. 6 at Hissar. 7 persons were killed and 4 injured in this accident. All of them were road users. The Gateman has been found responsible for this accident as he failed to close the gate of the crossing.

As the claims for compensation have not vet been filed by the next of the kins of the victims in the Railway Claims Tribunal, no compensation has been paid so far.
