Closure of Homeopatty Institute

- 1443. SHRI GURUDAS DAS GUPTA: Will the Minister of HEALTH AND FA-MILY WELFARE be pleased to state:
- (a) whether Governments' attention has been drawn to the news item appeared in "The Hindustan Times" dated November 19, 1992 to the effect that the Homoeopathy Institute faces closure;
- (b) if so, whehter it is a fact that the Supreme Court had ruled that the Director shall not exercise any financial powers on the working of the Institute or any of its units and these powers shall be exercised by the administrative officer of the Tns&tute independently as has been reported in the news-item;
- (c) if so, whether it is a fact that the said Director continued to use his powers as against the ruling;
- (d) whether Government are considering his extension inspite of his act? of ommissions and commissions; and
 - (e) if so, the details and reasons thereof?

- (b) No, Sir. However, it is presumed that Hon'ble Member is refering to a Calcutta High Court's order dated 17-3-92 restraining present Director in exercising certain financial and legal powers on working of the National Institute of Homoeopathy.
- (c) No such instances in exercising the ftnaiitial and legal powers by the present Director against the Calcutta High Courts order has come to notice of the Government Instance quoted in news item do not amount to exercise of r.ny financial powers.
- (d) and (e) No such proposal is under consideration of the Government.

Anti-TB drugs are supplied free of cost to the diagnosed TB patients irrespective of caste, creed or location from these Centres. Main emphasis is on domicilliary treatment and seriously ill patients requiring surgical intervention are refered to TB Hospitals / Sanatoriums where free treatment facilities are available.
