- (b) whether it is a fact that the buses seldom stop at the Bus Stops but stop nor mally in the middle of the roads blocking traffic and if so, the action proposed to be-taken in this regard?

## Declaration of State Highways as National Highways

1549. SHRI B. K. HARIPRASAD: Will the Minister of SURFACE TRANSPORT be pleased to state:

- (a) whether it is a fact that the Chitradurga- Tellicherry State Highway, which passes through Shimoga, Chickamagalur, Sakleshpur, Mercara and the State Highways of Bangalore-Calicut via Kanakapura Mallavalli, Mysore, Sulthanbatery, has been cleared by the planning Commission as National Hghways and if so, the details thereof: and
- (b) whether Government propose to take, on early decision and action in the matter in order to promote trade, commerce, tursim, industries employment generation and also National Security?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI JAGDISH TYTLER): (a) Yes, Sir. However, due to financial stringency it was decided to pend further consideration of the proposal till finalisation of the 8th Plan.

(b) Due to meagre allocation earmarked for Central Sector Roads during 8th Plan, it is difficult to consider declaration of new National Highways in the country including the roads in question.
