- (c) what steps are proposed to be taken to increase production of cottoni cloth;
- (d) what was the production of cotton cloth during the years 1989-90, 1990-91 and 1991-92; and
- (e) what is the target fixed for the year 1992-93?

THE MINISTER OF STATE OF THE MINISTRY OF TEXTILES (SHRI ASHOK GEHLOT): (a) Production of cotton cloth has been increasing for the last several years. However, there was a slight decline in the year 1991-92.

- (c) Textile Policy envisags maintenance of pre-eminent role of cotton as main raw material of Textile Industry. Government ils taking several measures like.
- (i) Modernisation of ginning and processing units.

- (ii) In the new Industrial Policy there is no restriction! on setting up of mill/ decentralised powerloom except locational restriction.
- (Hi) Textile Machinry can be imported and duty on such machinery had already been reduced in present budget.
- (iv) Textile Modernisation Fund was created in 1986 and upto the end of March, 92 sanctioned an amount of Rs. 1367 crores in respect of 357 cases out of which Rs. 836 crores have been disbursed in respect of 304 applications.
- (d) Production of cotton cloth was 12738 million sq. mts., 13398 million sq. mtrs, and 13039 million sq. mts respectively for the year 1989-90, 1990-91 and 1991-92.
- (e) As per VOT. Plan projections production of cotton cloth is estimated to be 14735 million, sq. mtrs, for 1992-93.
