port through its Chartering Wing, Charters the vessels for bringing in the imported cargo on behalf of Government of India. Once the vessels are fixed, FCI head-quarters, on receiving the fixtrue note which contains the details of vessel's Dimensions/Capacity discharge range etc., nominate the vessel to the best suitable ports at a particular point of time. The criteria of allocation depends upon the availability of berth at various ports and the suitability of vessel's dimension for operation and with the ultimate objective of having a quick turn around of the vessel.
