(a) and (b) The various State Governments have their own training institutions for imparting training to officers of the State Government in matters pertaining to Public Administration. In the Chief Ministers' Conference held on 14th September, 1992 on the subject of Human Rights, the importance of change in the administrative culture and induction of training as also refresher courses on Human Rights was noted. It was decided that concerted effort should be made in this direction to sensitise the administration

at various levels. The agenda also included a model course design on Human Rights for various types of officers dealing with vulnerable sections of society.
