

**Lifting or restriction on inter-state movement of fertilisers**

2624. **SHRI G. Y. KRISHNAN:** Will the **PRIME MINISTER** be pleased to state:

(a) whether Government propose to lift inter-state restriction on the movement of fertiliser through private channel keeping in view the satisfactory indigenous production of fertiliser and allowing import of DAP and other fertilisers under OGL; if so, what are the details thereof;

(b) if not, what are the reasons therefor; and

(c) what alternative measures Government propose to take to ensure that unused and surplus fertiliser in a particular zone should not get damaged due to inter state restrictions on the movement of fertiliser by the efficient/quick private channel?

**THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS & FERTILISERS (SHRI CHINTA MOHAN):**

(a) to (c) In respect of nitrogenous fertilisers allocations and movement to various States are made under Essential Commodities Act. The phosphatic and potassic fertilisers which have been de-controlled are not subject to any restriction on movement. All nitrogenous fertilisers which are under price control are allocated to the states on the basis of demand pattern. By and large, therefore, there should not be any surplus in respect of these fertilisers.

**THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS & FERTILISERS (SHRI CHINTA MOHAN):**

(a) to (c) A symposium entitled "Asian Symposium on Health Care Economics" was organised by the Organisation of Pharmaceutical Producers of India (OPPI) and co-sponsored by the International Federation of Pharmaceutical Manufacturers' Association (IFPMA), based in Geneva, of which OPPI is an affiliate member. They are an independent Industry organisation and Government had no part to play in the organisation of the Symposium.

As per the information received from the OPPI, the Symposium had been designed to bring together the members of the Health Care System and discuss the efforts to be made for achieving the ambitious targets set in the Health sector in the coming decades and thus meet public needs and expectations.

(d) and (e) One member Planning Commission, one Deputy Minister and a few senior officials chaired some of the sessions on the invitation of the organizers.
