THE MINISTER OF STATE OF THE MINISTRY OF FOOD (SHRI TARUN GOGOI): (a) The target of sugar production for the terminal year of the Eightl Five Year plan, viz 1996-97, has been fixed at 147.88 lakh tonnes.

- (b) During the season 1991-92, there were 410 installed sugar factories in the country and their capacity utilisation was 129.66%.
- (c) The co-operative sugar mills in Maharashtra have produced 40.06 lakh tonnes (provisional) of sugar out the of total production of 132.77 lakh tonnes (provisional) in the country during the season, 1991-92.
- (d) Formulation of a new incentive scheme to cover new sugar factories and expansion projects is presently under the consideration of Government.
- (e) The Licensing Policy guidelines for Sugar Industry for the sugar Year 1991-92 and the 8th Five Year Plan (1992-93 -1996-97) were announced vide press note dated 8.11.1991. In view of the large pendency of unimplemented letters of intent/industrial licences already issued, proposals for setting up of new sugar factorics have not yet been taken up for consideration. Obtaining finances from the Central Financial Institutions, etc. for new sugar factories is primarily the responsibility of the entrepreneur.
- (f) National Co-operative Corporation(NCDC), Development centrally Sponsored Scheme. under provides investment loan assistance to the State Governments for setting up of new cooperative sugar factories. Under the 8th Five Yeal Plan, a provision of Rs. 350 crores has been made for the scheme. During 1992-93, a provision of Rs. 48.66 crores has been made. However, NCDC

sanctions investment loan to State Governments only after the All- India financial institutions have apprised the project and have sanctioned the requisite term loan.
