## Maintenance of National Highway in Bihar

- \*328. SHRI PARMESHWAR KUMAR AGARWALLA: Will the Minister of SURFACE TRANSPORT be pleased to state:
- (a) whether it is a fact that the funds allocated to Bihar for maintenance of National Highways passing through the State are inadequate;
- (b) whether it is also a fact that the State Government is not fully utilising the above fund; and
- (c) if so, what action Government propose to take to maintain the highways which are not only important from the transport point of view but also important from national security point of view?

THE MINISTER OF STATE OF THE **MINISTRY** OF **SURFACE** TRANSPORT (SHRI JAGDISH TYTLER): (a) to (c) Yes, Sir. Due to constraints. of resources. present allocation of funds for maintenance of National Highways is running short of the requirements based on approved norms for all States/Union Territories including Bihar. The position regarding allotment for and expenditure on maintenance of National Highways in Bihar during the last three years is as under:—
