THE MINISTER OF STATE IN THE MINISTRY OF STEEL (SHRI SONTOSH MOHAN DEV): (a) broadly. Finished Steel is divided into two categories Non-Flat products and Flat products. The year-wise projected demand of Finished Steel during the Eighth Five Year Plan are as follows:

(b) After delicensing and deregulation of pricing and distribution of iron and steel, entrepreneurs are free to decide their product-mix keeping in view the demand and availability position. Import of all items of steel is also freely allowed. The items currently imported include mainly HR coils/Sheets, CR coils/Sheets, Plates, Electrical Sheet. Tin Mill Black Plates and Tin Plates.

In the prevailing market situation, some categories of steel like Plates, Bars and Boards and Structural will be exported by India, while some other categories of steel especially of specialised type will continue to be imported.
