(ख) और (ग) पिछले 3 वर्षों में गुजरात में 43 स्थानों पर भूकंपीय सर्वेक्षण और 65 स्थानों पर अन्वेषण वेधन किया गया है जिससे 8 स्थानों पर नयी खोजें हुई हैं जो पश्चिमी बेचराजी के आई एम, अन्दादा, जम्बूसर, नांदेज, प्लेज, सांगनपुर और दक्षिणी पटन हैं।

#### **Uncommissioned Agencies in Maharashtra**

Corporations area which have not been commissioned despite issuance of letter of intent and the re-advertisement of the dealerships town-wise and company-wise;

(b) the number of such uncommissioned agencies within the State of Maharashtra;

(c) the number of wait listed customers in the above metro and Municipal Corporations towns in Maharashtra; dealer-wise/location-wise;

(d) the reasons for non-commissioning of the agencies and the action proposed by Government; and

(e) whether it is a fact that Government propose to change the norms for selection of dealers in the above areas in such cases?

**THE MINISTER OF PETROLEUM AND NATURAL GAS (SHRI B. SHANKARANAND):** (a) and (b) There are 9 LPG distributorships in Bombay for which LOIs have been issued and which are yet to be commissioned.

(c) As on 1.10.1992, the Waiting List for the State of Maharashtra was 14.67 lakhs.

(d) These distributorships are under various stages of commissioning, for completing the necessary formalities and acquiring the required infrastructure.
