THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT **EDUCATION** DEPARTMENT AND OF CULTURE) (KUMARI SELJA): Committee headed (a) The by Malinit Bhattacharya, (Smt.) the Class Strength recommended that should be limited to 35 students per section and after even special dispensation admissions, it should not exceed the limit of 45. Wherever the class strength has exceeded the outer limit of 45, the Government should provide additional infrastructure.

(b) and (c) One of the measures being taken by Kendriya Vidyalaya Sangathan to cope with the higher enrolment in sections is to run a double shift, which has been introduced so far in 22 Kendriya Vidyalayas as per the enclosed statement. (see below)
