- (b) According to Delhi Admn., the number of vacancies of teachers in Urdu Medium schools which is less than that of other Govt. schools cannot be a major factor for unsatisfactory results.
- (c) The information is being collected from Delhi Admn. and will be placed on the Table of the Sabha.
- Admn. (d) Delhi has issued instructions to all Deputy Directors of Education for issuance of quick clearance of vacancies wherever required by aided schools management to enable them to fill up the vacant teaching posts expeditiously.

of national Policy on education (NPE) 1986, the NCERT brought out in 1988, a National Curricular Framework elementary and secondary education, revised the entire school syllabi and brought out revised textbooks for classes I to XII. Based on the Framework and the syllabi and textbooks brought out by the NCERT, the States and Union Territories have also undetaken measures of curriculum renewal and development of new text-books for different stages of school education for their introduction into the school system in a phased manner and in a few States, the process is still on. According to the NCERT, they have not received any objection to idea of a national curricular framework with a common core from any State or UT.
