Administration, 101 plots in Functional Industrial Estate for Electronics in Okhla have been allotted to enterpreneurs for setting up of electronic industries.

- (b) As per the latest survey report of that Administration, there are 15 allottees who have set up their electronics industries.
- (c) and (d) Some cases have come to the notice of that Administration where the allottees have started industries other than electronics. That Administration has been advising such allottees to switch over to electronics industry failing which appropriate action is taken depending upon the merits of each case.

KRISHNA SAHI): (a) and (b) The policy initiatives taken in the new Industrial Policy in July, 1991 the Trade Policy and supporting fiscal and monetary measures announced subsequently are together aimed accelerating the growth to industrial production. enhancing productivity. efficiency of the industrial sector and at improving our overall international competitiveness. These policy initiatives and measures and the external environment for trade mainly determine the level of export and imports. While it is not possible to isolate the impact of the new Industrial Policy and it is also premature to assess the overall impact of the changes in the Policy regime on the export performance and the level of imports, the provisional data shows that in US Dollar terms, exports increased by 5.1 per cent and imports by 251 per cent during April-September, 1992, as compared to the corresponding period last year.

The estimated capital cost for the manufacture of trainer aircraft at HEEP, Hardwar is Rs.5 Crores approx. The development of medical LINAC has been taken up mainly with the existing facilities. However, certain product specific testing facilities like high power micro-wave system and radiation free test station are being created at an estimated cost of Rs.40 lakhs.
