- (b) The Bill on Interest on Delayed Payments to Small Scale and Ancillary Industrial Undertakings to replace the Ordinance promulgated on 23.9.92 has been listed for introduction in Winter Session of Parliament. The proposed Limited Partnership Act is under active consideration of the Administrative Ministry, namely, the Ministry of Law, Justice and Company Affairs.
- (c) Various suggestions have made by different industry associations, including the Federation of Association of Small Industries of India, to improve the functioning of SSI units. Suggestions pertain to regarding credit, sickness, incentives and simplification of rules and procedures These issues have also envisaged in the policy statement for small scale units and were discussed in detail at the 42nd Meeting of the Small Scale Industries Board held on 24.8.92.
