- (a) whether it is a fact that a new scheme has been prepared to ensure security of Scheduled Caste/Scheduled Tribe and minorities:
  - (b) if so, what are the details thereof; and
- (c) whether it is also a fact that this scheme will be fully funded by the Central Government?

THE MINISTER OF WELFARE (SHRI SITARAM KESRI): <a) No Sir.

(b) and (c) Does not arise.

## Functioning of National Commission on SC/ST

4030. SHRI MATANG SINGH: Will the Minister of WELFARE be pleased to state:

- (a) whether it is a fact that the National Commission on SC and ST has complained about Government interference in its working and treating it as a subordinate office;
  - (b) if so, the details of the complaints;
- (c) what steps have been taken to ensure that the Commission discharges its assigned responsibilities freely; and
- (d) whether Government propose to take initiatives to strengthen the composition and functioning of the board?

(b) The Scheduled Castes Development Corporations (SCDCs) are service oriented organisation and are acting as catalysts and agencies for mobilising institutional finance through margin money loan programme/seed money. These activities are meant to play a useful role for the economic development of Scheduled Caste families below poverty line. The schemes undertaken for this purpose arc as per the Statement.

The schemes undertaken by various SCDCs are more or less same; still they vary from State to State in term of name and nature. Some common schemes are listed below:—
