- (b) what are the details of fertilisers allocation to Delhi along with names and addresses of the companies and quantity individually allocated during the last zonal meeting; and
- (c) by when the next Zonal meeting for fertiliser allocation to States and Union Territories is likely to be held and proposed target for each State?

THE MINISTER OF STATE IN THE OF **AGRICULTURE** MINISTRY (SHRI MULLAPPALLY RAMACHANDRAN): (a) and (b) Allocation of fertilizers to State Governments. Territories Union are made for Kharif and Rabi seasons separately. The supply plan giving details of allocations is laid in both Houses of Parliament. Phosphatic and potassic fertilisers stand decontrolled with effect from 25.8.1992. The fertiliser supply plan for current Rabi 92-93 season (October, 1992 to March, 1993) indicating details of allocation of fertilisers to individual States/Union Territories, including Delhi, along with the names of companies authorised to supply was laid on the Table of Raiva Sabha on 4.12.1992 [S.O.NO.842(E)], the copies of which are available in the Parliament Library.

(c) The next fertiliser zonal conference to assess the requirement of fertilisers for each State/Union territory for Kharif, 1993 season, in consultation with concerned state Government/Union Territory, is likely to be held in February/March 1993.

## Involvement of Manager, (Procurement), DMS in Bungling

3826. SHRI ABDUL SAMAD SIDDIQUI: Will the Minister of AGRICULTURE be pleased to state:

(a) whether it is a fact that Manager procurement of Delhi Milk Scheme was

placed under suspension and the suspension was revoked within 24 hours;

Sale of Butter Oil by DMS

3827. SHRI ABDUL SAMAD SIDDIQUI: DR. FAGUNI RAM:

Will the Minister of AGRICULTURE be pleased to state:

- (a) whether it is a fact that Delhi Milk Scheme has decided to sell Butter Oil at a loss;
- (b) if so, what are the details of the loss and whether it is also a fact that purchase of the Liquid Skimmed Milk has been stopped even at the cost of financial loss to Delhi Milk Scheme;
- (c) whether it is a fact that the offer for supply of Liquid Skimmed Milk at Rs. 3.25 per Kg., which would give

cheapest SMP/SNF, has been not accepted;

- (d) whther it is also a fact that this is being done at the instance of Contractors supplying mixed milk and the loss likely to be incurred by Delhi Milk Scheme due to non acceptance of the offer; and
- (e) if so, the action taken against the officials responsible for this losses?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI K.C. LENKA): (a) and (b) No, Sir. National Dairy Development Board (NDDB) from whom Delhi Scheme had procured in early 1992 the butter oil for use in the lean season has offered to take back the unutilised quantity of butter oil at the same rate it had supplied plus sales tax and transportation charges. The decision to return the butter oil to NDDB and to stop procurement of liquid skimmed milk has been taken keeping in view the overall cost economics with the advent of flush season from November, 1992 when the commitment of Delhi Milk Scheme to procure fresh milk as per the existing agreements increased.

- (c) and (d) Neighther the offer of single party for supply of liquid skimmed milk at Rs. 3.25 per kg was accepted in view of the reply to (a) and (b) above nor has this decision been influenced by any contractor.
- (e) Does not arise in view of reply to (a) to (d) above.

Purchase of Mixed Milk by D.M.S.

3828. SHRI ABDUL SAMAD SIDDIQUI: DR. FAGUNI RAM:
