- (c) if so, what are the details in this regard; and

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) According to the information furnished by the University Grants Commission, 9 Universities are offering courses in Defence studies/Military Science at the Graduate and Postgraduate levels.

(b) to (d) According the information furnished by Union Public Service Commission, the Commission examinations conducts various accordance with the Rules notified by various Ministries / Departments. The Schemes of examinations, laid down in the Rules are finalised by the Commission in consultation with the Government of India. At present, there is no proposal under consideration of the Commission for inclusion of Defence studies and allied subjects in the scheme of competitive Examinations.

Percentage of Female Illiterate

3879. SHRI S.S. AHLUWALIA: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether it is a fact that female illiterate in Bihar, Madhya Pradesh, Uttar Pradesh and Rajasthan which was

- 45 per cent in 1981 had increased to 48 per cent in 1991;
- (b) if so, what are the details thereof, State-wise: and
- (c) what action Government propose to take to remove female illiteracy in these States?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT CULTURE) (KUMARI SELJA): (a) and (b) The percentage of female illiterates in the State of Bihar, Madhya Pradesh, Rajasthan and Uttar Pradesh compared to the total female illiterates in the country increased from 45.6% in 1981 to 46.8% in 1991. However, the female illiteracy rate in those States has shown a gradual decreasing trend between 1981-91 as given in the table below:

of (c) Universalisation Elementary Education, Non-formal Education for the drop-outs and the National Literacy Mission, which aims at imparting functional literacy to 80 million adult illiterates in the 15-35 age-group form part of a larger strategy for the eradication of illiteracy in the country in general and in the States of Bihar, Madhya Pradesh, Rajasthan and Uttar Pradesh in particular. The focus of all these programme is, on girls and women. The number of NFE centre sanctioned, the number of blocks which have been covered under 'Operation Blackboard' (OB) and the districts which have been
