THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA) (a) Yes, Sir. (b) and (c) Delhi Administration has informed that as per the memorandum dated 30.11.92 submitted by Delhi Adhyapak Parishad, the demands are:—

(i) Removing anomalies in the Pay Scale and grant 3rd Pay Scale for all teachers.

ii) Equitable Medical Care at least comparable to the other Govt. servants in Delhi.

iii) Teaching Allowance be merged into the pay scales for all purposes.

(d) The pay scales of school teachers were revised in August, 1987 effective from 1.1.86. There is no proposal under consideration of Government to revise further the pay scales of school teachers or to merge other allowances with pay. As regards medical care, Govt. have requested Delhi Administration to work out details for a comprehensive Health Insurance Scheme in consultation with teachers in lieu of medical allowance.

**Shifting of Post-Graduate Courses in Calcutta University**

(a) whether sufficient funds have been released by UGC to the University of Calcutta for holding post-Graduate classes; and

(b) whether Government would take immediate steps to ensure the implementation of the proposed shifting of Post-Graduate Section of Economic classes to the new premises at Alipore?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF

EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA) (a) UGC provides financial assistance to eligible Universities for purchase of books, journals and equipment, recruitment of staff, construction of buildings and hostels. The Commission also provides financial assistance under specific Schemes. According to the information furnished by UGC, the Commission has allocated an amount of Rs. 145.00 lakhs to Calcutta University for the 8th Plan out of which grant amounting to Rs. 59.00 lakhs have since been sanctioned. Recurring grants for holding post-graduate classes by the University are not provided by the UGC.

(b) Calcutta University has been set up by an Act of the Legislature of West Bengal, and as such, an appropriate decision in this regard will have to be taken by the State Government itself.
