order to further enhance the image and status of the profession.

- 3. IFLA/UNESCO should compile and publish a manual providing guidance on the preparation of library and information legislation and policy, codes of ethics and statutory recognition of the profession based on experience in book the developing and developed countries in order to upgrade the quality of services and enhance professional performance.
- 4.1 IFLA, through its Division for Education and Research should prepare guidelines on curriculum content which should also include the teaching of the concept of professionalism, education entry levels, teaching and other support faculty for consideration of library schools at national level.
- 4.2 Library associations and other lead agencies at national level should provide programmes in continuing education to enhance professional capability.
- 4.3 Library associations should function as national accreditation bodies where appropriate.
