(d) by when a decision is likely to be taken?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA) : (a) According to the information furnished by the University Grants Commission, 9 Universities are offering courses in Defence studies /Military Science at the Graduate and Postgraduate levels.

(b) to (d) According to the information furnished by Union Public Service Commission, the Commission, conducts various examinations in accordance with the Rules notified by the various Ministries/Departments. The Schemes of examinations, laid down in the Rules are finalised by the Commission in consultation with the Government of India. At present, there is no proposal under consideration of the Commission for inclusion of Defence studies and allied subjects in the scheme of competitive Examinations.
