

### Foreign Auctioners in India

3875. SHRI MENTAY PADMANABHAM : Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether it has come to the notice of Government that the reputed London Auctioners "SOTHEBYS" have started their operations in India;

(b) whether Government have stipulated any guidelines before permitting them into the Indian market;

(c) if so, the details thereof;

(d) whether it is also a fact that in the recent auctions of So thebys, they have violated these guidelines; and

(e) if so, the action taken in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) Yes, Sir. The auction was conducted on 8th & 9th October, 1992 at New Delhi as per the catalogue published by Sothebys.

### Defence Studies in the Universities

3876. SHRI VIREN J. SHAH : Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether it is a fact that there are about 28 Universities in the country which conduct undergraduate courses and 13 Universities at post-graduate level on the subjects Defence studies and allied subjects;

(b) whether there is any proposal under Government's consideration for including defence studies and allied subjects in Union Public Service Commission examinations both at graduate level and post-graduate level;

(c) if so, what are the details in this regard; and

(d) by when a decision is likely to be taken?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA) : (a) According to the information furnished by the University Grants Commission, 9 Universities are offering courses in Defence studies /Military Science at the Graduate and Postgraduate levels.

(b) to (d) According to the information furnished by Union Public Service Commission, the Commission, conducts various examinations in accordance with the Rules notified by the various Ministries/Departments. The Schemes of examinations, laid down in the Rules are finalised by the Commission in consultation with the Government of India. At present, there is no proposal under consideration of the Commission for inclusion of Defence studies and allied subjects in the scheme of competitive Examinations.
