

Opening of a sub-Post Office at Basot in Almora

4191. SHRIMATI VEENA VERMA: Will the Minister of COMMUNICATIONS be pleased to state:

(a) whether it is a fact that residents of Basot have represented for opening a sub-Post Office at Basot in Almora;

(b) whether it is a fact that they have also requested for opening of branch post office at Kota; and

(c) if so, by when a sub-post office at Basot and branch post office at Kota will likely to be opened?
