Setting up of loan recovery Tribunals

4246. SHRI KRISHNA KUMAR BIRLA; Will the Minister of FINANCE be pleased to state:

- (a) whether there is any proposal under Government's consideration to set up loan recovery tribunal for banks;
- (b) if so, the purpose of setting up loan tribunals for banks;
- (c) what are t!he details modelities of setting up such tribunals; and
- (d) by when these tribunals would be set up and to what extent the loans would be recovered by the banks?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI DAL BIR SINGH): (a) to (d). Government has decided to set up Special Tribunals for recovery of dues of banks ana finan cial institution over a specified limit. These Tribunals would help in reducing the existing delays in settling the disputes regarding dues of banks and financial institutions, avoid blocking of their funds in prolonged litigations and also improve their financial strength. The Tribunals are proposed to be set up under a act of Parliament and necessary legis lation is under preparation. 180
