THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI P.V. RANGAYYA NAIDU): (a) Yes, Sir.

(b) The proposal has been dropped on cost considerations and because of practical difficulties.

Modernisation of Postal Services

THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI P.V. RANGAYYA NAIDU): (a) and (b) A Committee has been constituted to review the Indian Post Office Act 1898 and make recommendations. The terms of reference of the Committee are:

- I, to examine the Act in all the aspects, with particular reference to:
- (i) the developments in communication by mail in the country in recent years and the likely trends in the future, and the challenges from them to the Post Office,
- (ii) the developments in international postal system and the responsibilities that they impose on the Post Office,
- (iii) the difficulties felt by the Post Office in practice on account of the limitations of the Act,
- (iv) the needs of the society for different Postal services,
- (v) the increasing social awareness as to the obligations of the Postal system and its social accountability, and

(vi) the legal liability that the Post Office should accept for its services, in the context of the growing consumer protection trends, and consistent with the magnitude of its services, the conditions under which they are rendered and the relative tariffs.

THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI P.V. RANGAYYA NAIDU): (a) Tender bids for cellular phones were finalised in two stages. In the first stage the bids were technically and commercially evaluated giving due consideration to technical specifications, commercial and eligibility conditions as given in the tender. Out of the 30 bidders who participated in the 1st stage of tender, 14 bidders were short listed and financial hids issued to them.

In the second stage the financial bids from the short listed bidders were evaluated and 8 bidders were provisionally selected.
