THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SHANTARAM POTDUKHE): (a) to (c) As already indicated on page 12 of the Receipts Budget for 1992-93, the surplus profits to be transferred by RBI to Government in the current year is estimated at Rs. 1500 crores and the increase follows the decision to discontinue the practice of appropriating large amounts from the profits of RBI for advancing loans to industrial and agricultural financial institutions before transferring the surplus to Government. This will enable Government to meet its expenditure to a larger extent from revenue receipts instead of borrowings and thus help containment of the fiscal deficit.
