(a) whether it is a fact that the film unit of Delhi Doordarshan has been lying idle since early this year;

(b) if so, what are the reasons therefor;

(c) whether it is also a fact that Delhi Doordarshan library is in a pitiable condition; and

(d) if so, what steps Delhi Doordarshan propose to take to maintain the film unit and the library on a sound footing?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION & BROADCASTING (KUMARI GIRIJA VYAS): (a) and (b) With the adoption of latest technology by Doordarshan, the film unit has become obsolete and the processing plant is being -shifted to F.T.I.I., Pune.

(c) and 'of There has been congestion

in the Library on account of accumulation of archival material. However, expansion of the Library has been done and it is being reorganised.

#### **Survey for Assessing the popularity of AIR and Doordarshan Entertainment Programmes**

Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) whether any detailed sample statistical surveys have been conducted all over India so far to assess and evaluate public opinion on quality and likability of the entertainment programmes broadcasted and telecasted by All India Radio and Doordarshan, respectively;

(b) whether Government are aware of the fact that the entertainment programmes of both the media are banal and stereo typed; and

(c) what steps are being taken by Government to improve the quality as to the prime aspect of attracting all cross-sections of people in the country?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS): (a) Yes, Sir.

(b) The audience surveys conducted by All India Radio and Doordarshan during 1991-92 reveal that the entertainment programmes broadcast/telecast by All India Radio/Doordarshan continue to be popular with the general public.

(c) It has been the constant endeavour of All India Radio and Doordarshan to improve the quality of their programmes, including entertainment programmes.
