

country, if so, the steps Government propose to overcome these problems?

**THE MINISTER OF CIVIL AVIATION AND TOURISM (SHRI MADHAVRAO SCINDIA):** (a) The foreign tourist arrivals upto October 1992 and during the previous years since 1986 except during 1990 and 1991 have exceeded the targets. The decline in tourist arrivals during 1990 and 1991 was due to various international and internal problems including the Gulf War.

(b) The endeavour of the Government is to improve the tourism amenities in the country with the co-operation of State Government and private sector.

(c) The availability of adequate infrastructure is a bottleneck in the growth of tourism in the country. However, the Central Government gives financial assistance to State Governments for augmenting tourism infrastructure based upon specific projects, their *inter-se* priority and the availability of funds.

#### Conversion of palaces into hotels

**28. SHRI JAGIR SINGH DARD:**  
**DR. ABRAR AHMED:**

Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state:

(a) whether the Central Government are negotiating with some former maharajas of princely states to convert their palaces into hotels;

(b) if so, the details thereof; and

(c) what are the results achieved in this regard so far?

**THE MINISTER OF CIVIL AVIATION AND TOURISM (SHRI MADHAVRAO SCINDIA):** (a) to (c) A new category of 'Heritage Hotels' has been introduced to cover functioning hotels in palaces, castles, havelies, forts, etc. built prior to 1950. Guidelines for approval at project stage for conversion of heritage properties into hotels have also been formulated to provide additional room capacity for tourists and to preserve these landmarks of our

heritage. So far 17 Heritage hotels providing 568 rooms have been approved.

#### Summer Saver Plan for tourists

**DR. ABRAR AHMED:**

Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state:

(a) whether Government have any summer saver plan with discount in air fare and hotel tariffs to attract foreign tourists; and

(b) if so, what are the details thereof?

**THE MINISTER OF CIVIL AVIATION AND TOURISM (SHRI MADHAVRAO SCINDIA):** (a) Yes, Sir. A Summer Saver Plan was offered to foreign tourists jointly by Air India, Indian Airlines and the hotel industry for the period from 1 Apr.—30 Sep. 92

(b) Air India offered 30% to 40% discount while Indian Airlines offered 15% on US\$ fare. ITDC offered various discounts going upto 60% on its selective hotels. Some private hotels also offered discounts ranging between 40 and 50%.

#### Expansion of Calicut Airport

**30. SHRI E. BALANANDAN:** Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state:

(a) whether there is any proposal for the expansion of the Calicut airport;

(b) if so, what are the details thereof;

(c) whether 'AIR INDIA' is considering a proposal to start flights of Gulf countries from Calicut; and

(d) if so, the details thereof?

**THE MINISTER OF CIVIL AVIATION AND TOURISM (SHRI MADHAVRAO SCINDIA):** (a) Yes, Sir.

(b) The National Airports Authority has plans to construct a separate new International Terminal suitable for handling 250 outgoing and 250 incoming passengers, at an estimated cost of Rs. 613 lakhs. The architect has been appointed and the drawings have been
