HIV cases in Assam

265. SHRI BHADRESWAR GOHAIN: Will be Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether any case of HIV has been detected in Assam in the recent months; and

(b) if so, what steps are taken by the Government to prevent the increase of such dreaded disease in Assam?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRIMATI D.K. THARADEVI SIDDHARTHA):

(a) Only one case of HIV infection has been reported in Assam during the last six months. Four cases of HIV infection have been detected in Assam so far.

(b) The Government of India has launched a Centrally sponsored scheme for implementation by the all States/ UTs. with World Bank and W.H.O. assistance for the prevention and control of AIDS in the country. The accent is on prevention as AIDS has no cure, as of now. The programme components

consist of strengthening management, increasing the level of awareness in community and among individuals, increasing safety of blood and blood products, augmenting STD control Programme and improving clinical management and surveillance.
