

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MALLIKARJUN): (a) The Route Kilometre per 100 Sq. Km. in Orissa was 1.29 (Provisional) as on 31.3.1992.

(b) The National Average ratio of route km. per 100 Sq. Km. was 1.90 (Provisional) as on 31.3.1992. It was more than that of Orissa by 0.61 Route Kms. per 100 Sq. Km. as on 31.3.1992.

(c) and (d) 336 Route Kilometres are proposed to be laid in Orissa during the Eighth Five Year Plan. Rs. 656.85 crores have been sanctioned for the purpose.

Encroachment of railway land

(a) what is the area of total Railway land which is under encroachment in Mughalsarai and Varanasi; and

(b) what action is being taken to remove the encroachments?

(a) Mughalsarai=0.129 Hectare
Varanasi=4.656 Hectare

(b) For removal of encroachments on railway land, action is taken under the Public Premises (Eviction of Unauthorised Occupants) Act, 1971.

(SHRI MALLIKARJUN): (a) The total no. of cases with value of Railway property including booked consignments reported stolen from Mughalsarai station limits during the last three calendar years is as under:—

(b) Surprise rounds and frequent raids under the strict supervision of RPF Officers in Co-ordination with GRP Officers posted at Mughalsarai station are conducted. Besides, armed pickets and patrolling are done regularly to keep crime under control.

(ख) यदि हां, तो क्या यह भी सच है कि रेलवे ने उक्त बैंक को ब्याज के रूप में 13 मिलियन डालर की घनरशि का भुगतान भी कर दिया है यद्यपि विद्युत रेल इंजन की खरीद के संबंध में अभी तक कोई अंतिम निर्णय नहीं लिया गया है;
