# **Botanical Survey of India**

255. DR. SHRIKANT RAM-

CHANDRA JICHKAR: Will the Minisof ENVIRONMENT FORESTS be pleased to state:

- (a) the annual expenditure of the Botanical Survey of India;
- (b) .how much is 'spent on the salaries and emoluments of its employees; and
- (c) whether any analysis has been made on the work being done by the Botanical Survey?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI AR-JUN SINGH): (a) The annual expenditure of the Botanical Survey of India (BSI) during the financial year 1990-91 was Rs. 5.78 crores.

- (b) The total amount spent on salaries and emoluments of its employees during 1990-91 was Rs. 4.48 crores.'
- (c) A review of the functioning of the BSI was done in 1987 and its objectives and priorities have been redefined so as to achieve the targets by 2000 AD. Government have also constituted a Programme Advisory Committee to review the work being done by the BSI and its sister organisation, the Zoo logic a! Survey of India (ZSI), and to suggest new areas of study and research.

### Congress Grass in Maharashtra

256. SHRI RAMDEO BHANDARI: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- (a) whether Government arc aware of 'Congress Grass' in Maharashtra, the seed of which had come to India alongwith the PL 480 wheat imports;
- (b) whether the Botanical Survey of India has made any cco-study about the problems created by this grass;

- (c) whether Government are aware of the amount and area of land that has become waste and crops and forests damaged due to the rapid growth of this grass; and
  - (d) if so, what are the details thereof?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) It is learnt that the species *Parthenium hysterophorus* Linn (Family Asteraceae) was recorded in West Bengal as early as 1845. The occurrence of the same specices also known as "Congress Grass' was reported from Punc in 1956. It is stated that the Weed was introduced through foodgrains under the PL-480 Scheme.

- (b) Scientists of the Botanical Survey of India have observed and studied the features of "Congress Grass', and also the possibilities of using other species to check the growth of the weed.
- (c) and (d) Congress Grass has currently occupied large areas of agricultural and non-agricultural land in the States of Maharashtra and Karnataka. However, no data is available about the exact area of its spread.

- (b) The expenditure on the emoluments of the employees of the Museum during the financial year 1991-92 was Rs. 31.92 lakhs.
- (c) The total strength of the Museum staff is 122.
- (d) 10 members of the staff of the Museum have visited museums in other parts of the world.

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) The State/Union Territory Government of Gujarat, Sikkim, Dadar and Nagar Haveli, West Bengal, Maharashtra, Himachal Pradesh, Haryana, Andaman Nicobar Islands, Punjab, Tripura, Daman & Diu, Rajasthan, Mizoram, Orissa and Meghalaya have reported datection of 21181 cases under the Prevention of Cruelty to Animals Act 1960 during the last three years.

- (b) Acts of Cruelty were generally committed against Buffaloes, Camals, Goats, Sheeps, Cows, Dogs, Bulls, Monkeys and birds.
