THE MINISTER OF STATE IN THE MINISTRY OF CIVIL SUPPLIES AND PUBLIC DISTRIBUTION (SHRI KAMA-LUDDIN AHMED) ': (a) The total quan-

thty of price, wheat and imported edible oils allotted to Uttar Pradesh for the Public Distribution System (PDS) in 1992 are respectively 4. 15 lakh tonne's 7.14 lakh tonnes and 4,500 tonnes.

(b) and (c) Central Government makes bulk allocations of PDS commodities to States/UTs including Uttar Pradesh on a monthly basis taking into account the stocks in Central Pool, demands received from the States, inter-se requirements of various States/UTs, seasonal factors etc, PDS allocations are supplemental in nature and are not intended to meet the total re* quirements of any State/UT.
