THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) to (c) The total number of students in Kendriya Vidyalayas in the State of Jammu & Kashmir in 1991-92 was 18764 and in the State of Punjab was 31128.

The Kendriya Vidyalaya Sangathan does not maintain data on outside students in Kendriya Vidyalaya. However, a large number of students migrated from Kashmir Valley during 1990-91 were admitted in various Kendriya Vidyalayas in the country.

Financial Powers of A.I.C.T.E.

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) and (b) Eventhough the AICTE Act empowers the AICTE to allocate and disburse funds to the technical institutions, universities etc. and also to withhold discontinue the grants, the Council not yet taken up this task for want adequate administrative machinery. question of refusal by the Government or any agency to refuse financial hold has not arisen. The Ministry of Human Resource Development or the University Grants Commission provide funds either as direct assistance or for specific projects only to the approved institutions.

- (c) Once the AICTE gears up its administrative machinery and also launches various programmes and schemes, transfer of funds would not pose any problem.
- (d) There are a few cases of affiliation for Pharmacy & Management Institutions without the prior approval of the AICTE and also of affiliation of unapproved technical courses.
- (e) The number of engineering colleges in the country which are not yet approved by the AICTE is of the order of 150.
