- 9. The Commission has also been actively contributing to increase awareness generation and mobilisation of women, through participation in conferences and meetings organised by Government agencies and voluntary organisations in several States.
- 10. The Commission has been balding periodical meetings with lady Membears of Parliament, women profes sionals in the media, etc. to staytuned to the current thinking on relevant issues and to exphanege ideas. It has been meeting represen tatives of women's voluntary orga nisations at structured sessions as well as at informal meetings.

- (c) and (d) In addition to the various schemes of the States/UTs to provide basic facilities in their schools, the Central Government launched the Centrally-sponsored Scheme of Operation Blackboard (OB) from 1987-88 to bring about substantial improvement in facilities in Primary schools. This scheme has the three following interdependent components :-
  - (i) Provision of two pucca classrooms with a deep "Yarandah and separate toilet facilities for boys and girls.
  - (ii) Provision of atleast two teachers and as far as possible, one of them a
  - (iii) Provision of essential teachinglearning material.

During the period from 1987-88 to 1991-92, the OB Scheme has been implemented in 84% of the blocks comprising 77% Primary Schools. The Scheme will be continued during the VIII Plan period.

THE MINISTER OF HUMAN DEVELOPMENT **SOURCE** (SHRI ARJUN SINGH): (a) and (to) Under the Scheme of setting up of Employment-cum-Jncome generating units for women, 250 projects have been sanctioned since the inception of the Scheme. A statement indicating the number of such projects in each State/U.T. is annexed (see below). The assistance given under the Scheme in the last two years is as under:-

> 1990-91 Rs. 200 lakhs 1992-93 Rs. 200 lakhs

The following criteria is followed for extending assistance under the Scheme :-

- 1. The project must have a substantial training input.
- 2. The implementation of the project must be the responsibility of a Government of a Non-Governmental organisation acceptable to Government.
- 3. The project must have poor and needy women in urban and rural areas as the major target group.

- 4. The emphasis of the project must be on income generating activities with the aim of achieving self-employment on a sustained basis.
- 5. The project must be sustainable on a long term basis.
- (c) When a project is sanctioned to an organisation, the first instalment of the sanctioned cost consisting of 100% of the nonrecurring and 50% of the recurring cost is released. The second instalment consisting of the balance amount is released only after the applicant organisation submits quarterly progress reports of the project and a utilisation certificate signed by a Chartered Accountant for the amount released as first instalment. On completion of the project, the organisation is required to give again, a utilisation certificate for the total amount released to it. The beneficiary organisation is also required to maintain records of the trained women who have been employed and also those who have not yet obtained sustained employment. Quarterly Progress Reports from the organisations during the training period are to be submitted and after the training is completed six monthly project reports for a period of five years on the employment status of the trainees are to be submitted by the organisation.

OF CULTURE) (KUMARI SELJA): (a) to (c) Though Urdu language is not taught as a subject there is a provision for additional teaching of regional language or mother tongue to children in Kendriya Vidyalayas where there are 20 or more students willing to learn a language including Urdu. This is done by local arrangement at the school level according to the need whenever arises. Kendriya Vidyalaya Sangathan has not received any representation that this provision has not been implemented.
