THE MINISTER OF STATE OF THE MINISTRY OF FOOD (SHRI TARUN GOGOI): (a) There is no restriction on inter-State movement of levy-free rice. wheat, coarsegrains and oilseeds. In view of the need to maximise procurement of rice for public stocks, the State Government of Andhra Pradesh, Karnataka, Haryana, Uttar Pradesh (in certain divisions) Chandigarh Administration, have however, imposed inter-State movement restrictions on paddy. Madhya Pradesh, Rajasthan, Pondicherry and Tamil Nadu have allowed movement outside their respective State of paddy after payment of 25%, 25%, 30% and 50% export levy respectively.

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA) : (a) According to the information given by the NCERT, there is no shortage of the textbooks in Arunachal Pradesh. The NCERT does not distribute its textbooks in the State. At the beginning of each acedemic session the Government of Arunachal Pradesh makes advance payment to the NCERT for purchase of the NCERT textbooks, Workbooks and Supplementary Readers and asks its Delhi representative to make arrangement for lifting the requisite number of such books from Delhicampus of the NCERT and their despatch to various destinations in the State. Out of 132 titles of NCERT books requisitioned for the 1992-93 session, adequate number of copies of 127 titles were lifted by the State Government during the period from 13-4-92 to 20-7-92 for supply of copies of the remaining 5 titles, the State Government has made advancement payment on 27-10-92 and the titles are being lifted by their representative.

- (b) It is not true that the NCERT changes its School Curricula frequently. The last change in the School Curricula was done on the basis of the guidelines of the National Curricular Framework brought out by the NCERT in 1988, keeping in view the postulated of the National Policy on Education, 1986.
