#### Free Education for Girls

855. SHRI ANANTRAY DEVSHANKTR DAVE. : Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state :

, (a) whether Government propose to make free girl child education scheme for standard-I, upto Graduation in the country to promote education among them; and

(b) if so, the details in this regard ?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPTT. OF EDUCATION AND DEPTT. OF CULTURE) (KUMARI SELJA) : (a) and (b) No such proposal is under consideration. Education for girls is free upto elementary stage in government schools in all States and Union-Territories. Some States and UTs have extended this facility to girls studying in secondary/senior secondary schools and upto college stage also. Others have not been able to do so because of financial constraints.

#### Memorandum received by Government

856. SHRI GAYA SINGH : Will the Minister of HUMAN -RESOURCE DEVELOPMENT be pleased to state :

(a) whether Government have recently received some Memorandum sent through the officers of Assistant Commissioners of Kendriya Vidyalaya Sangathan's 15 Regi-

onal Offices and Collectors of some districts;

(b) if so, what are the details thereof; and

(c) what is Government's reaction thereto ?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPTT. OF EDUCATION AND DEPTT. OF CULTURE) (KUMARI SELJA) : (a) to (c) Yes, Sir. All India Kendriya Vidyalaya Teachers' Association, one of the Teachers' Association, had forwarded a Memorandum through the Regional Offices and some District Collectors raising various issues relating mainly to representation of employees in the Kendriya Vidyalaya Sangathan and its Board of Governors, Rationalisation of Joint Consultative Machinery and other routine administrative matters. The Kendriya Vidyalaya Sangathan has held discussions on 16th & 17th November, 1992 with the representatives of the AIKVTa and other teachers' Associations.

#### Budget of the Indian Institute of Science

857. SHRI VIREN J. SHAH : Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state :

(a) whether Government have approved the budget of the Council of the Indian Institute of Science for the year 1992-93;

(b) if so, when it was approved;

(c) when the sanction was conveyed to the Council of I.I.S.;

(d) whether it is a fact that the delay in conveying the Government's sanction to IIS has made its functioning extremely difficult;

(e) if so, what are the reasons for the delay; and

(f) what steps Government have taken in this regard ?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA) : (a) to

(c) The University Grants Commission has allocated a maintenance grant of Rs. 18.64 crores to Indian Institute of Science, Bangalore, for the year 1992-93 and the allocation was conveyed to the institute by the Commission on 2nd April, 1992.

(d) to (f) The three instalments of maintenance grant each amounting to Rs. 4.66 crores were sanctioned to the institute in April 1992, July 1992 and September 1992 respectively. The last instalment will be released in January 1993. UGC has been releasing the grants to the Institute regularly.

#### **Guidelines for Central Assistance to Universities**

858. SHRI H. HANUMANTHAPPA : Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state :

(a) what are the guidelines of the University Grants Commission for Central assistance to the Universities;

(b) whether Kuvempu University of Karnataka has submitted its proposals for financial assistance; and

(c) if so, what are the details in this regard ?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA) : (a) According to the information furnished by UGC, the Commission has notified Rules for declaring Universities fit to receive Central assistance. Every University has to fulfil certain conditions laid down in these Rules before it can be declared fit by UGC for such assistance. Under the Rules, a University is required to have, inter-alia, adequate assets/facilities in terms of buildings, equipment, library, hostels and staff quarters, minimum teaching staff alongwith the necessary supporting staff for teaching and research.

lb) and (c) According to the information furnished by UGC, a proposal has been received by the Commission from Kuvempu University for financial assistance. However, the University has not yet been dec-

lared fit to receive Central assistance as it does not have the required number of teaching posts and the prescribed minimum number of books in the library. The University has since been advised by the Commission to remove these deficiencies in the first instance.

#### **National Policy on Libraries and Information System**

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state that what steps Government have taken to implement the National Policy on Libraries and Information Systems and to develop the infrastructure of Libraries ?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA) : This Ministry set up a Committee to formulate a nation-wide policy on library and information system. The Committee submitted its report which has been examined in detail and lines of action have been drawn up. A small implementation Cell has been created to take action on the various recommendations of the Committee.

'Library' is a State subject and there is no single agency which has control over all the libraries. Each library functions under the control of its parent organisation/Department/Ministry of the Central and State Governments. The development of infrastructure of libraries is the concern of these respective agencies. As regards the libraries under the Central Government, measures are taken from time to time to improve their infrastructure.
