## Supply of Milk by Delhi Milk Scheme

761. SHRI SHIV PRATAP MISHRA: Will the Minister of AGRICULTURE be pleased to state:

- (a) whether it is a fact that Delhi Milk Scheme has been supplying milk prepared from skimmed milk;
  - (b) if so, the details thereof;
- (c) whether it is also a fact that Delhi Milk Scheme has stopped to procure fresh milk from the open market; and
  - (d) if so, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI K. C. LENKA): (a) and (b) Yes, Sir. Delhi Milk Scheme (DMS) supplies toned/ double toned milk by standardising fat and solids-not-fat (SNF) received from mixed

milk/cow milk. The additional quantities of fat and SNF are taken from white butter/butter oil and skimmed milk powder/ skimmed milk. In order to consume the slocks of available milk fat, DMS had to resort to reconstitution of milk with Skimmed Milk Powder. However, due to non-availability of adequate quantity of SMP, DMS had to procure skimmed milk as a substitute of skimmed milk powder.
