#### Supply of Milk by Delhi Milk Scheme

761. SHRI SHIV PRATAP MISHRA : Will the Minister of AGRICULTURE be pleased to state :

(a) whether it is a fact that Delhi Milk Scheme has been supplying milk prepared from skimmed milk;

(b) if so, the details thereof;

(c) whether it is also a fact that Delhi Milk Scheme has stopped to procure fresh milk from the open market; and

(d) if so, the reasons therefor ?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI K. C. LENKA) : (a) and (b) Yes, Sir. Delhi Milk Scheme (DMS) supplies toned/double toned milk by standardising fat and solids-not-fat (SNF) received from mixed

milk/cow milk. The additional quantities of fat and SNF are taken from white butter/butter oil and skimmed milk powder/skimmed milk. In order to consume the stocks of available milk fat, DMS had to resort to reconstitution of milk with Skimmed Milk Powder. However, due to non-availability of adequate quantity of SMP, DMS had to procure skimmed milk as a substitute of skimmed milk powder.

(a) and (b) The total amount of indemnity claims paid and number of farmers benefited during the last three years in Maharashtra under the Comprehensive Crop Insurance Scheme (CCIS) are as follows :—
