The Committee appointed to review the standard list of equipments of a new sugar factory with a view to reducing the project cost has submitted its report which has been accepted by the Government and ils recommendations have been forwarded to the concerned State Governments.

Concession to Sugar Factories in Maharashtra

THE MINISTER OF STATE OF THE MINISTRY OF FOOD (SHRI TARUN GOGOI): The question of inclusion of the expenditure incurred on harvesting and transportation while fixing the levy price of sugar has been referred to the Bureau of Industrial Costs and Prices (BICP) who have been asked to undertake a fresh

investigation into the cost structure of the sugar industry for fixing the levy sugar prices for the sugar years 1993-94 to 1995-96.

Sale of Sugar by new Sugar Units

816. SHRI SURESH KALMADI: Will the Minister of FOOD be pleased to state:

- (a) whether it is a fact that Government propose to allow new sugar units to sell 88 per cent produce in the market;
 - (b) if so, the reasons therefor; and
- (c) what would be the impact of this decision on the existing sugar units?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD (SHRI TARUN GOGOI); (a) to (c) Formulation of a new incentive scheme to cover new sugar factories and expansion projects is presently under the consideration of Government.

Warehouses in Maharashtra

- 817. SHRI JAGIR SINGH DARD: Will the Minister of FOOD be pleased to state:
- (a) the number of warehouses under the Central Warehousing Corporation in the State of Maharashtra;
 - (b) what is their total capacity; and
- (c) what is their turnover, quantity and value-wise?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD (SHRI TARUN GOGOI): (a) The Central Warehousing Corporation, as on 1-10-92, has been operating 66 Warehouses and 4 Container Freight Stations in Maharashtra.

- (b) 7.60 lakh tonnes.
- (c) The capacity utilisation of the Corporation in Maharashtra, as on 1-10-1992, was 66%. The value of the stocks held in storage on that date was Rs. 174.65 crores.
