

(b) if so, what are the details thereof ? and

(c) what concrete steps have been taken so far by Government to save the township from danger ?

THE DEPUTY MINISTER IN THE MINISTRY OF COAL (SHRI S. B. NYA-MAGOUA) : (a) and (b) Problems of land subsidence, mainly exist in the Raniganj Coalfield of Eastern Coalfields Ltd., due to unscientific exploitation of coal during pre-nationalisation days. 45 locations in 4 Asansol-Raniganj area of West Bengal have been identified as unsafe areas based on the declaration of Director General of Mines Safety, Govt. of West Bengal and the areas listed by Central Mine Planning and Design Institute in the Master Plan of Raniganj Coalfield.

(c) With a view to checking the growth of habitation over unsafe areas, the Govt. of West Bengal had passed legislation in 1979 prohibiting construction in such unsafe areas. There is no proven method of stabilising inaccessible, water-logged, old abandoned workings of Raniganj Coalfields. Eastern Coalfields Limited, has however, developed through Research and Development, a system of hydropneumatic method of stowing for stabilising water-logged, inaccessible workings and at present a part of the Raniganj township has been taken up for stabi-

lisation under the supervision of an 'Apex Monitoring Committee' constituted by the State Govt. of West Bengal and Coal India Limited. Necessary remedial measures are taken by the management of ECL to shift the affected persons due to subsidence as and when required.
