There have been a series of explosions, bomb blasts in public places and attacks, on security forces and vital installations. In the first week of Oct. 1992 explosion took place in a Bus in the outskirts of Jammu city and in the last week of Oct. 1992, in a private Bus plying between Vijaypur and Samba (Jammu). In both these incidents, large number of people were either killed or injured. There have been a number of attacks on security forces and police outposts. The Microwave Station at Banihal was attacked and damaged leading to disruption in communication links with parts of the Valley.

Written Answers

(b) In order to curb militancy in the Jammu Region, possible infiltration routes have been identified and, security has been tightened to check in infiltration. Additional para military forces have been deployed and concerted efforts are being made to flush out the militants and weapons from the area.
