(c) The Government has been reviewing all the implications of the ban on the approved Space Programmes during the Eighth Plan period and feels confident that with suitable adjustments, the impact of the embargo on our national space programme can be minimised. In view of the actions already taken by ISRO to guard against such contingencies, it is hoped that the ban for two years might not affect the launch vehicle or satellite programmes planned for next two years. In order to ensure that extension of embargo beyond two years will also not affect our programme, long term measures as appropriate with necessary outlays to ensure timely action for self-reliance are also underway.
