

**Operation of actrtion platforms of F.C.V.
Tobacco**

2745. DR. YELAMANCHILI SIVAJI; Will the Minister of COMMERCE be pleased to refer to Unstarred Question 1849 given in the Rajya Sabha on 10th March, 1992 and state;

(a) what is the number of days for which the auction platforms remained dosed during the current year;

(b) what is the number of days each platform, remained) in operation;

(c) what are the platform-wise details thereof; and

(d) what are the reasons for irregular operation of the platforms?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI SALMON KHURSHEED): (a) and (d) The number of days for which auction platforms remained closed and the reasons thereof are given below:

15 auction platforms remained closed from 14.4.92 to 1-5-92 due

to agitation by growers demanding better prices for tobacco.

AM the 23 auction platforms remained closed from 19-4-92 to 22 4-92 due to boycotting of auctions by the staff in protest against the man-handling of the auction superintendent at Ongole-II platform by some farmers.

At Nandigama auction platform auctions could not be conducted from 30.3.92 to 6-4-92 due to boycotting the auctions by buyers they were man-handled by growers.

At Podili auction platform auctions could not be conducted from 20.3.92 to 6-4-92 due to boycotting the auctions by the traders as a buyer was man-handled.

Except the above mentioned incidents, auctions, were running smoothly at all the places.

Radio paging system in Hyderabad

2746. DR. NARREDDY THULASIREDDY; Will the Minister of COMMUNICATIONS be pleased to state,

(a) whether there is any proposal under Government's consideration to install Radio Paging System in Hyderabad;

(b) if so, what are the details thereof; and

(c) what are the advantages of this system?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI P. V. RANGAYYA NAIDU); (a) Yes, Sir.

(b) The Government has invited tenders for franchise radio paging service in 27 cities. Hyderabad is one of these.

(c) Any telephone user can access the paging subscribers anywhere in its area of operation and pass coded messages (the calling telephone number etc.) to paged subscribers. The paged subscriber can in turn contact the original caller for the details of the message.
