(b) if so, whether the State Bank of India is now contesting the claim of the NHB and has even decided to go to court in this matter;

(c) whether it is also a fact that the ANZ Grindlays Bank has refused to pay in a similar situation; and

(d) if so, what action Government propose to take in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI DAL-BIR SINGH): (a) No, Sir.

(b) State Bank of India has reported that it has initiated action to file a claim on the assets of Shri Harshad S. Mehta under the provisions of Special Court (Trial of Offences Relating to Transactions in Securities) Ordinance, 1992 for recovery of the amount

(c) In compliance with the Reserve Bank of India directive, the ANZ Grindlays Bank has made a provision of Rs. 506 crores in their books, without prejudice to their legal rights and contentions. However the payment to NHB has not yet been made.

(d) This is a matter for Reserve Bank of India to take necessary action.

(MADHAVRAO SCINDIA): (a) to (c) The extension of runway to 9000' and construction of a separate terminal block at Ahmedabad airport in Gujarat has been completed during the last three years. The installation of speech switching system at this airport is in progress.

These works have been executed as per schedule during the last three years.
