#### Prevention of asthma

2914. SHRI B. K. HARIPRASAD: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether Government's attention has been drawn to the article which appeared in the Hindustan Times of 4th July, 1992 by Neelam Mathews on the subject of Asthama;

(b) if so, Government's reaction thereto;

(c) the number of people who are affected by Asthama State-wise and sex-wise, including children indicating the loss of productivity of these affected persons;

(d) whether any surveys have been conducted and results tabulated for ready reference and use by our various R and D units and if so, salient features thereof; and

(e) whether Government have any plans to educate the people on the preventive side and if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRIMATI D. K. THARA DEVI SIDDHARTHA): (a) Yes, Sir.

(b) to (e) No statistics are specifically maintained regarding the Asthama patients in the country. However, a statement showing cases and deaths due to Bronchitis, chronic and unspecified emphysema and Asthama in various States/UTs of India during the years 1987 to 1990 is enclosed as Annexure. [See Appendix CLXIV, Annexure No. 46]. Patients who seek treatment are guided about the pre-

cautions to be taken to prevent asthma from causative agents and allergens.

(d) what are the measures taken/proposed to be taken to improve the availability of medicines and prevention of the epidemic?
