Forests along Eastern Ghats

*412. SHRI RAJUBHAI A. PAR-MAR:

SHRI MURLIDHAR CHAN-DRAKANT BHANDARE:

Wi'l the Minister of ENVIRON-MENT AND FORESTS be pleased to state:

- (a) whether it is a fact that the 150 km. stretch of Niligiri type canopy and deciduous forests along the Eastern Ghat, is threatened by the exploitation of large bauxite reserves of over 200 million tonnes estimated to be lying underground there; and
- (b) if so, what steps are being taken to ensure preservation of the forests and the eco-system while exploiting the bauxite reserves?

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH): (a) No, Sir. Approval under the Forest (Conservation) Act, 1980 for diversion of forest land for non-forestry purposes including for bauxite mining is accorded after considering all the relevant aspects including likely effect of mining on flora and fauna
