Revised policy on allocation of newsprint

- 3199. SHRI SUBRAMANIAN SWA-MY: Will the Minister of INFORMA-TION AND BROADCASTING be pleased to state:
- (a) whether it is a fact that Government have recently announced a revised policy on allocation of newsprint;
 - (b) if so, what are the details thereof;
- (c) whether it is a fact that due to this policy the newspapers are forced to buy indigenous newsprint only from a few selected paper mills;
- (d) the number of small mills in the private sector manufacturing and supplying newsprint and what is their total capacity:
- (e) whether it is also a fact that the indigenous manufacture of newsprint by these mills have led to a saving of foreign exchange:
- (f) if so, what steps Government propose to take to ensure that these mills do not close down:
- (g) whether Government have received any representation from any of the small mills in the private sector;
 - (h) if so, the details thereof; and
- (i) what is Government's reaction thereto?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS): (a) and (b) Yes, Sir, On 5-5-1992 the Government notified new Guidelines for issue of Certificate for Entitlement of newsprint for the licensing year 1992-93. Copies of the Guidelines have been made available in the Parliament House Library.

(c) Indigenous newsprint allocated by Registrar of Newspapers for India to newspapers who are entitled and apply for it is required to be purchased from the newsprint mills specified in Schedule I of the Newsprint Control Order, 1962, as amended from time to time,

- (d) There are about 296 small and medium paper mills manufacturing vairous types of paper and paper board with an annual installed capacity of 17.19 lakh tonaes in the country.
- (e) and (f) Indigenous manufacture of newsprint leads to saving of foreign exchange. Taking suitable measures for the sustained growth of the paper industry is a continuous process.
- (g) to (i) Some paper mills have requested for their inclusion in the Schedule I of the Newsprint Control Order. Two mills have recently been included in Schedule I of the said Order.
