

been a Controlled item. The level of controls differ from country to country. For countries which are non-signatories to the nuclear non-proliferation treaty, computers above a certain threshold can be exported only after a license is obtained from the US Government. India is included in this category.

(b) The matter has been taken up with the Government of USA.

(c) Since high performance computers will be subject to case by case licensing, there will be delays in procurement.

(d) and (e) The import of items of high technology including computers are undertaken under the provisions of the Indo US Memorandum of Understanding signed in 1984. Government are pursuing proposals for procurement of computers from the US under this agreement.

Visit of Israeli team to India

in March 1992, to discuss the broad

framework of future political and economic bilateral relations.

(c) Visits of delegations in the fields of civil aviation, tourism and agriculture have taken place to draw up programmes of cooperation in each of the areas.
